4. The District & Sessions Judge, Karak shall transfer the criminal/civil cases to the Court of Mr. Muhammad Iqbal Khan, newly posted Additional District & Sessions Judge from his court as well as the court of Additional District & Sessions Judge-, Karak keeping in view the principle of equal distribution.
5. The newly posted Civil Judge-cum-Judicial Magistrate, Allai shall tour Batagram thrice a week for the disposal of criminal and civil cases to be entrusted to him by the District & Sessions Judge, Batagram.
