

# **PESHAWAR HIGH COURT, PESHAWAR**

## **NOTIFICATION**

Dated Peshawar the 30<sup>th</sup> July, 2025

**No. 274 -J** In exercise of the powers conferred by Article 202 of the Constitution of the Islamic Republic of Pakistan, 1973, Hon'ble the Chief Justice and Judges of the Peshawar High Court, Peshawar are pleased to direct that in Chapter 10, Part-A, Volume-V of the High Court Rules and Orders, the following amendments shall be made, namely: -

### **AMENDMENTS**

#### **1. Substitution of Rule 2.**

For the existing Rule 2, the following new rule shall be substituted:

"The Administration Committee shall consist of the Chief Justice with Senior Puisne Judge and three most senior Judges of the High Court."

#### **2. Substitution of Rule 3.**

For the existing Rule 3, the following new rule shall be substituted:

**"3. Quorum of Administration Committee:** - At all meetings of the Administration Committee, 'three' Judges shall form a quorum.

If any Member of the Administration Committee is not available, the work assigned to him will be disposed of by the Senior Puisne Judge and in case of Senior Puisne Judge, by the Chief Justice."

#### **3. Amendment in Rule 4.**

In Rule 4, clause (b), sub clause (xviii), items (a) and (b) shall be omitted.

#### **4. Amendment in Rule 9.**

In Rule 9, for the word "**four**" occurring twice, the words "**50% of the total working strength of the High Courts' judges**" shall be substituted.

#### **5. Amendment in Rule 16.**

In Rule 16, clause (vi), for the word "**three**" the word "**four**" shall be substituted.


