NOTIFICATION

Dated Peshawar the 12th May 2020

In public interest and to protect the Hon'ble Judges of this Court working at the Principal Seat at Peshawar, Officers and Staff of the Principal Seat against Corona (Covid-19) Pandemic and for the reason that recently a couple of staff members were found positive for the said lethal Virus now therefore the Competent Authority has for the ibid purpose pass following directives: -

- a. The Principal Seat of Peshawar High Court at Peshawar shall be lockdown from **13th to 31st May 2020** that is to say that all offices, branches, Basic Health Unit, Bar Room, Advocate General Block, Consultation Room, Bar Library, Book shop, Service Shed of paralegal staff shall be closed except for essential staff of General Branch, Protocol, Security, Accounts Branch/ Nazir and AR(Mgt) offices.
- b. Two Single Benches shall be functional. Institution Branch shall only receive Bail matters and release copies of Bail related matters only.
- c. Two Principal Staff Officers shall work in rotation. The officers belonging to out districts, ladies, and staff belonging to out districts likewise lady staff shall be exempted from this duty. The AR (Admn) shall however be on duty throughout that period to personally supervise the protective & precautionary measures to be taken to disinfect and sanitize the Principal Seat at Peshawar.
- d. All staff of Principal seat shall give affidavit as per proforma enclosed to the effect that neither they nor their immediate relatives (spouse, issues, parents, brothers and sisters) their neighbors where immediate or distant are diagnosed with or suspected of corona (Covid-19) infection. In case of this affirmative deposition the staff members would be under obligation to produce a Laboratory test report of being not infected with Corona (Covid-19) Virus. For this purpose, they may resort to Police Services Hospital or DHQ Hospital of their locality or any private laboratory. - e. In case staff fails to give this affidavit or was later found to be false disciplinary proceedings shall be initiated against him.
- f. The Staff members reporting in affirmative of being infected with corona covid-19 shall be immediately quarantine and on their return on 1st June they would be bound to produce lab test report showing that he has recovered thus is negative for the said virus.
